Terms & Conditions for Membership in the Global Child Forum Impact Network

(v. 1; 4 Nov 2025)

1. 1. MEMBERSHIP DURATION AND RENEWAL

- **Initial Term:** In the first year, membership begins on the date the membership fee is received and remains valid until **31 December** of that same year.
- **Subsequent Terms:** From the second year onward, membership is valid for a **full calendar year (1 January–31 December)**.
- **Renewal:** Membership is automatically renewed on **15 January** each year unless terminated in writing by either party prior to that date. Renewal is dependent on timely payment of the annual membership fee and continued alignment with Global Child Forum's values.

2. MEMBERSHIP FEE

- The annual membership fee (2026) is 10K EUR. A discounted fee is offered to SMEs: 3,5K EUR and to non-corporates: 1K EUR.
- An invoice will be issued upon signing of the commitment, and payment is due within 30 days unless otherwise agreed in writing.
- Annual renewal invoice will be issued on **15 January (renewal date)**.
- The annual membership fee is subject to change. Any changes will be communicated in writing at least 60 days prior to the renewal date.
- Failure to pay the membership fee may result in suspension or termination of membership.

3. CANCELLATION AND TERMINATION

- Either party may cancel the membership by providing written notice **at least 30 days prior to the renewal date**.
- Cancellation must be submitted in writing to membership@globalchildforum.org.
- No refunds will be issued for cancellations made after the renewal date unless otherwise agreed.

4. NON-TRANSFERABILITY

Membership is non-transferable and applies solely to the organisation named in the agreement.

5. MEMBER RESPONSIBILITIES

Members are expected to:

- Share relevant experience and insights through the Annual Progress Report at the end of each membership year.

- Engage in good faith with the network's activities and initiatives.
- Work to improve their organisation's impact on children's lives.

6. USE OF BRANDING AND COMMUNICATIONS

- Any use of Global Child Forum's name, logo, or branding must be approved in writing prior to publication.
- Likewise, Global Child Forum will seek approval before using the member's branding in public communications.
- Global Child Forum may name the member organisation as a member on <https://globalchildforum.org> or other communications materials for informational and recruitment purposes.
- Approvals should be provided within a reasonable timeframe and not be unreasonably withheld.

7. BADGE ACCESS AND USAGE

- After payment, members receive access to a badge to showcase their commitment.
- The badge is not a certification or rating and cannot be used in any way that implies such an interpretation.

8. CONFIDENTIALITY

Both parties agree to maintain the confidentiality of proprietary or sensitive information exchanged during the membership period, unless otherwise agreed in writing.

9. EXCLUSION FROM MEMBERSHIP

Global Child Forum reserves the right to exclude any member if actions or values conflict with the UNCRC or Global Child Forum's Child Safeguarding Policy. In such cases, membership fees will not be refundable.

10. DISPUTE RESOLUTION

- Any disputes shall first be addressed through good-faith negotiations.
- If unresolved within 30 days, the matter shall proceed to mediation in Stockholm, Sweden, under Swedish Mediation Institute rules.
- If mediation fails, arbitration will follow under SCC rules in Stockholm, in English.
- Each party bears its own costs unless otherwise determined by the arbitrator.
